

# **Internship Agreement**

On a full/part time basis for the purpose of training the intern in the following occupation:

- 4. Instruct the intern in the learning experience as described in the attached Training Plan.

- 5. Update the VWWC with any changes to this internship agreement.

## TRAINING PLAN

During the course of this internship, your employer will be responsible for your training and day to day work. You will be learning the following:

#### **QUALIFICATIONS**

To qualify for the internship program, an intern must

- Be 18 years of age or older
- Provide their own transportation
- Provide their own housing
- Be of sound physical condition to be able to participate in required work

### Employer participants must

- Be a member of the Vermont Woodworks Council in good standing. If they are not a member they have the opportunity to join.
- Be able to provide workers compensation insurance as required by law.
- Have a member of staff dedicated to mentor/manage the intern through the duration of the internship.
